The customs office then collects the import duty and VAT. The form is available at military customs offices. VHICs are not issued abroad. Evidence of this may be provided by the following documents: a declaration from the manufacturer that the vehicle was in free circulation in the European Union at the time of delivery; a German registration document; in this case, where appropriate, no duties or taxes will be levied if the documents submitted show that the tax on the amount of business (VAT) has already been paid. Representation is only possible by another member of the armed forces in possession of a written authorisation, or by an authority of the same armed forces, except for the removal of personal effects resulting from a secondment/removal. The authorisation is valid for 90 days from the date of issue. By the fifth day of each month at the latest, veterans must present their pink card to the issuing German customs office together with all original cash register receipts for purchases made in the previous month. Currently the following duties apply: Vehicle type/Duty Car and trucks (including trucks and pickups up to 2.5 liters) 10%; Truck (including trucks and pickups over 2.5 liters) 22%; Motorcaravan 10%; Motorcycles 6-8% (depending on capacity) Lá Import VAT is at the standard rate of 19%, calculated on the basis of the value of the goods including the tax payable. OTHER EUROPEAN ACCESSES Access for veterinarians to other European facilities, such as those in Italy, Belgium, the United Kingdom and the Netherlands, is still pending. If it is already known, before the journey, which goods are to be purchased, the import permit should be issued in good time. For more information on VHIC, please visit . This requires the prior approval of the armed forces. 1025, Room 102, on Clay Kaserne. 1, 2020, some veterans received access to the services of the Commissariat and Exchange. The goods will then be released. Forms must be returned to Installation Access Control Services via encrypted email, delivered in person at the Clay Kaserne Visitor Center, or IACS staff can provide a secure website link to which veterans can upload completed forms. To gain access to the installation and a Pink Card to make purchases, veterans must be registered with the Department of Veterans Affairs. TEDESCA CUSTOMS REGISTRATION Form AE 550-175K must be presented to the German customs office for further processing and issuance of the actual authorization, Forms 0216 and 0217, which is also indicated as a pink card. Once the background checks are completed within three to five days, the IACS will notify Veterans that they can go to the Clay Kaserne Visitor Centre to obtain an installation permit. If it is not possible to ship them by post, the goods can be sent from the country of origin or from the German border customs office to the nearest customs office (this requires the lodging of a security deposit), where final customs clearance will take place. In addition, a customs declaration must be lodged if the goods are sold, the sales invoice shall also be presented and an electronic customs declaration for the goods shall be presented. The competent customs office ("the office in whose area transaction or transfer is to take place. Once stamped by military customs, the form must be presented to competent customs office at or near the borders your base. Please note the following: You have to produce two original copies of authorization both signed in original. The authorization not be transferred to suppliers, agents, transporters or other unauthorized persons. Customs provide the veteran with a status check module, AE Form 550-175K, which will be presented to German customs, or Zollamt. Goods acquired duty-free by a member of the armed forces which are to be transferred or sold to a non-beneficiary shall be customs cleared by a customs office. For items with a unit price lower than US dollar equivalent of 50 euros, the duties will be charged at 17.5% VAT (German Value Added Tax). Similarly it is possible to purchase a duty-free vehicle from a German customs warehouse. Under the new authorization, eligible veterans include Purple Heart recipients, former POWs, and disabled veterans service-related documents or their documented VA assistants. Usually, the US Armed Forces (Application for import/export certificate/purchase permit, formerly Form AE 2075), the British Armed Forces (BFG) 80 form, or a similar document from other states' armed forces, is accepted as an authorization. If the vehicle had been released for free circulation in the Community immediately before purchase you will be only VAT on import. Veterans who go only to Germany can get a temporary installation card with their VHIC through the same procedure.
